On June 13, 2025, notice (the “**Conditional Notice of Full Redemption**”) was given by Inter Media and Communication S.p.A. (the “**Issuer**”) in accordance with Section 3.03 of the indenture dated as of February 9, 2022 (the “**Indenture**”) by and among, *inter alios*, the Issuer, The Law Debenture Trust Corporation p.l.c. as trustee and security representative (*rappresentante*) of the Holders (the “**Trustee**”), Intesa Sanpaolo S.p.A. as security agent (the “**Security Agent**”), The Bank of New York Mellon, London Branch, as principal paying agent (the “**Paying Agent**”) and The Bank of New York Mellon SA/NV, Luxembourg Branch, as registrar and transfer agent, pursuant to which the Issuer issued its €415,000,000 6.750% Senior Secured Notes due 2027 (the “**Notes**”).

The terms not otherwise defined herein shall have the same meanings given to them in the Conditional Notice of Full Redemption.

The Condition has been satisfied on June 24, 2025. Therefore, on the Redemption Date (being June 26, 2025), the Issuer will redeem, in accordance with the terms set out in the Conditional Notice of Full Redemption, all Notes not previously delivered to the Paying Agent for cancellation at a redemption price of 101.6875% of the principal amount of such Notes, plus accrued and unpaid interest to, but not including, the Redemption Date.
